

# Mobilization Bill

## A BILL

To establish the legal framework for martial arts.

*Be it enacted by the House of Representatives of the Republic of Vindex Nation in Congress assembled,*

### SECTION 1. **SHORT TITLE.**

This Act may be cited as the Mobilization Act 2024.

### SEC. 2. **DEFINITIONS.**

As used in this Act, the term—

“Reservist” means a person who is a member of a military reserve force;

“Military reserve force” means a military organization whose members, also known as reservists, may have civilian occupations in addition to their military occupation; and

“Pre-planned mission” means a task or operation that has been designed and organized in advance.

### SEC. 3. **RESERVES.**

(1) The Vindex Nation Armed Forces may raise a reserve component whose purpose is to provide trained units and qualified persons available for active duty in the armed forces, in time of war or national emergency, and at such other times as the national security may require, to fill the needs of the armed forces whenever, during and after the period needed to procure and train additional units and qualified persons to achieve the planned mobilization.

(2) Any individual mobilized into active military service is guaranteed their previous position or employment prior to activation.

### SEC. 4. **MOBILIZATION.**

(1) The Vindex Nation Congress may, by declaration of war or national emergency, authorize the mobilization of every online Vinish and non-foreign citizen into active military service, and may last until 14 days after the war or emergency for which it was declared.

(2) The Vindex Nation Congress may, by declaration of war or national emergency, authorize the mobilization of  $\frac{3}{4}$  of online Vinish and non-foreign citizens into active military service, and may be activated for no more than 60 days.

(3) The President of Vindex Nation may, by notifying Congress, authorize the mobilization of  $\frac{1}{2}$  of online Vinish and non-foreign citizens into active military service for up to 20 days.

(4) The Secretary of Defense or the President may, in response to emergencies, authorize the mobilization of  $\frac{1}{4}$  of online Vinish and non-foreign citizens into active military service for up to 10 days.

(5) The Chief of Staff of the Army, Chief of Naval Operations, Secretary of Defense, or the President may activate every reservist.

(6) A commander pre-planned mission authorizes the Chief of Staff of the Army, Chief of Naval Operations, Secretary of Defense, the President, or a commissioned officer authorized by any of the previously mentioned individuals, to activate  $\frac{3}{4}$  of reservists for a pre-planned mission for up to 30 hours.

(7) A reservist may voluntarily request to go on active duty if the activation is approved by the President.

(8) The following government officials are exempt from involuntary mobilization into active military service:

- a. President of Vindex Nation;
- b. Vice President of Vindex Nation;
- c. Speaker of the House of Representatives;
- d. Chief Justice of Vindex Nation;
- e. Secretary of State;
- f. Secretary of the Treasury;
- g. Secretary of Defense;
- h. Attorney General;
- i. Secretary of Commerce;
- j. Secretary of Health and Human Services;
- k. White House Chief of Staff;
- l. Director of Office of Management and Budget;
- m. Director of National Intelligence;
- n. Vindex Nation Trade Representative;
- o. Associate Justices of the Supreme Court; and
- p. members of Congress.

## **SEC. 5. CRIMES AND PENALTIES.**

(1) Unless exempt by law, any person evading a lawful mobilization or activation into military service, shall be punished by imprisonment no longer than 25 minutes and/or a fine no more than \$10,000.

(2) Any employer who fails to reinstate a person who was activated or mobilized into active military service or who discriminates against a person based on their past, present, or future military service shall be punished by a fine no more than \$1,000.
