# Termination of Judicial Authority Bill

#### A BILL

To dissolve the Judicial Branch of the Vindex Nation government and allocate its duties to alternative branches for the purpose of streamlining governance, and for connected purposes.

Be it enacted by the House of Representatives of the Republic of Vindex Nation in Congress assembled,

#### SECTION 1. SHORT TITLE.

This Act may be cited as the "Judicial Dissolution Amendment".

# SEC. 2. **DEFINITIONS.**

As used in this Act, the term—

"Judicial Functions" refer to the powers, duties, and responsibilities previously held by the Judicial Branch, including the interpretation of laws, judicial review, and the administration of justice through courts.

"Executive Branch" refers to the leadership of the President of Vindex Nation and their cabinet, responsible for enforcing laws.

"Legislative Branch" refers to the elected body responsible for creating laws and overseeing governance.

#### SEC. 3. REPEAL OF JUDICIAL BRANCH.

# 1. Dissolution of the Judicial Branch

The Judicial Branch, as defined in Section 5 of the "TEA 2024," is hereby dissolved. All courts, including the Supreme Court and lower courts, shall be disbanded, and their powers shall be reallocated as outlined below.

# 2. Reallocation of Powers

# (a) Interpretation of Laws

The interpretation of laws previously managed by the Judicial Branch shall be reassigned to the Legislative Branch. The House of Representatives will vote on any ambiguities or legal disputes regarding the meaning and application of the laws. A simple majority is required to confirm the interpretation.

#### (b) Judicial Review

The authority to conduct judicial reviews shall be vested in the **Office of the Legal Advisor to the President**, a new department established within the Executive Branch. The Legal Advisor shall review legislation and executive orders for compliance with the Constitution and other supreme laws.

# (c) Dispute Resolution

All legal disputes, civil or criminal, will be handled by an **Adjudication Committee** formed by representatives of the Legislative and Executive branches. The committee will comprise three representatives, one nominated by the President, and two elected by the House of Representatives.

#### (d) Issuance of Warrants

The Hon. Mansa Olanrewaju II (for himself, The Hon. Mansa Olanrewaju II, and Mr. Tyler Mort Finkelstein) introduced the following Bill

Warrants previously issued by judges shall now be issued by the **Director of Law Enforcement** within the Executive Branch, with oversight by the Adjudication Committee. Probable cause remains a requirement for issuing warrants.

# SEC. 4. APPOINTMENT OF LEGAL ADVISOR AND ADJUDICATION COMMITTEE.

# 1. Office of the Legal Advisor

The President shall appoint a **Legal Advisor**, who shall serve at the discretion of the President. The Legal Advisor's term is indefinite, unless removed by the President.

# 2. Formation of Adjudication Committee

The Adjudication Committee shall be formed by a joint resolution of the Legislative and Executive branches within one week of this act's passage and one week after the beginning of every congressional term hereafter. The Committee will serve as the final arbitrator for disputes, and decisions shall be reached by a simple majority.

#### SEC. 5. TRANSITIONAL PERIOD.

- 1. All pending cases under the jurisdiction of the former Judicial Branch will be transferred to the Office of the Legal Advisor and handled under new procedures within 14 days of the passage of this amendment.
- 2. Any laws or articles referencing the Judicial Branch in previous acts, including but not limited to "TEA 2024", are hereby amended to reflect the dissolution of the Judicial Branch and the reassignment of its duties.

#### SEC. 5. RATIFICATION AND IMPLEMENTATION.

1. This amendment shall be implemented immediately upon receiving ratification by four (4) out of five (5) sitting representatives and the signature of the President of Vindex Nation.
