A BILL

To establish the Class-2 Weapon Regulation Act for the purpose of enhancing public safety, streamlining law enforcement efforts, and regulating the possession of Class-2 weapons within Vindex Nation.

Be it enacted by the House of Representatives of the Republic of Vindex Nation in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the "Class-2 Weapon Regulation Act."

SEC. 2. INTENTIONS.

The intentions of this Act are to:

- (a) Reduce Criminal Activity: Deter the use of Class-2 weapons by individuals engaged in criminal activities.
- (b) Support Law Enforcement: Provide clear guidelines for the management of Class-2 weapon possession, thereby alleviating the workload of law enforcement agencies.
- (c) Maintain Public Safety: Ensure responsible citizens can access necessary means for self-defense while minimizing risks to public safety.

SEC. 3. DEFINITIONS.

As used in this Act, the term—

"Class-2 Weapons" refers to the following:

- 1. Sniper Rifles
- 2. Thompson Submachine Guns
- 3. AK-47 Assault Rifles

SEC. 4. ELIGIBILITY FOR CLASS-2 LICENSE.

- (a) Government Officials: All government officials and employees are permitted to possess and use Class-2 weapons under appropriate circumstances.
- (b) Law-Abiding Citizens: Citizens wishing to possess Class-2 weapons must:
 - 1. Apply for a Class-2 license through the Attorney General, Police Chief, or President
 - 2. Maintain a crime-free record for a minimum of two weeks prior to application.
 - 3. Upon approval, receive a Class-2 license book documenting the individual's name, license approval date, and time.

SEC. 5. ENFORCEMENT AND PENALTIES.

- (a) Custody for Criminals: Individuals arrested while in possession of a Class-2 weapon will be held in custody as follows:
 - 1. 15 minutes per Class-2 weapon, with a maximum of 30 minutes.
 - 2. If a Class-2 weapon is surrendered, remaining custody time will be adjusted accordingly.
 - (b) Confiscation of Weapons: The Vindex Police Department may search properties for

unregistered Class-2 weapons if an individual refuses to surrender their weapons upon arrest.

SEC. 6. FUTURE AMENDMENTS.

- (a) Implementation of Logging System: A new arrest logging system will be established to streamline law enforcement processes, potentially simplifying the Class-2 license acquisition process.
- (b) Review and Amendments: The laws governing Class-2 weapons will be periodically reviewed to ensure effectiveness and adaptability to changing circumstances.

SEC. 7. RATIFICATION AND IMPLEMENTATION.

This Act shall be implemented immediately upon receiving ratification by a majority of the sitting representatives and the signature of the President of Vindex Nation.
